ORDINANCE 12-12

AMENDING ORDINANCE 11-1

BE IT KNOWN AND REMEMBERED that pursuant to public notice at a regularly scheduled meeting of the Board of Aldermen of the Village of Maurice was held on the 19<sup>th</sup> day of December, 2012, where the following motion was moved, duly seconded, passed, and adopted, to-wit:

BE IT ORDAINED by the Board of Aldermen of the Village of Maurice, as governing authority of said Village, declare that:

WHEREAS, from time to time the Louisiana State Uniform Construction Code adopts revisions or amendments to the codes and requires each governmental entity subscribing to said code amend its ordinances to reflect the most recent revisions or amendments;

WHEREAS, the process and procedure can result in untimely amendments resulting in the ordinance requiring compliance with an outdated code;

WHEREAS, the Louisiana State Uniform Construction Code has suggested that governmental entities revise their ordinances to provide for the automatic implementation of a revised or amended code once it has been approved by the said Louisiana State Uniform Construction Code.

NOW, THEREFORE, in order to implement its findings, the following amendment to Ordinance No. 11-1 shall be added and apply:

“B. All future revisions and amendments by the Louisiana State Uniform Construction Code to each of the Codes referred to in (a) hereof shall be automatically adopted by reference.”

BE IT FURTHER RESOLVED that this ordinance was approved by the Board of Aldermen of the Village of Maurice after the same ordinance as duly presented to, examined, considered, approved, and adopted in an open meeting on the 19<sup>th</sup> day of December, 2012, at the place first written above.

WHEREUPON, the above Ordinance was read and submitted to a vote, the vote thereon being as follows:
