

**VILLAGE OF MAURICE**

**ORDINANCE 20-6C**

Ordinance Prohibiting Firearms or Dangerous Weapons in the Village of Maurice’s Municipal Buildings

\*\*\*\*\*

**BE IT ORDAINED** by the Mayor and Board of Aldermen of the Village of Maurice, Louisiana, acting as the governing authority of said Village that:

The Village of Maurice, Louisiana, does hereby adopt Ordinance Number 20-6C:

**BE IT ORDAINED** that it is hereby passed by the Board of Aldermen of the Village of Maurice that:

A. Possessing a firearm or dangerous weapon as defined by Louisiana Revised Statute 14:2 not exempted in Subsection B hereof, in the Village of Maurice’s municipal building or public building or structure utilized as the meeting place of the governing authority of the Village of Maurice is unlawful.

B. The provisions of this section shall not apply to a federal law enforcement officer, or a Louisiana-commissioned state or a local post certified law enforcement officer who is authorized to carry a firearm.

C. Whoever commits the offense of possessing a firearm or dangerous weapon as defined in Louisiana Revised Statute 14:2 in the Village of Maurice’s municipal building or public building or structure utilized as the meeting place of the governing authority of the Village of Maurice shall be subject to prosecution in Mayor’s Court punishable by a fine to not exceed \$500.00 or incarceration for not more than 60 days or both.
