**AMENDING ORDINANCE NUMBERS 08-09A, 0-77-6A, 6-8-77, and 11-7**

**AN ORDINANCE AMENDING ORDINANCE NUMBERS 08-09A, 0-77-6A, 6-8-77, and 11-7 TO ESTABLISH A FLAT RATE OF \$31.25 TO ALL RESIDENTS AND/OR COMMERCIAL ESTABLISHMENTS NOT CONNECTED TO THE VILLAGE OF MAURICE WATER SYSTEM AND REMOVING “RESIDENCE NOT DOMICILED IN THE VILLAGE OF MAURICE AND/OR NOT CONNECTED TO THE VILLAGE OF MAURICE WATER SYSTEM**

**BE IT ORDAINED** by the Mayor and Board of Aldermen of the Village of Maurice, Louisiana, acting as the governing authority of said Village that: The Village of Maurice, Louisiana does hereby amend Ordinance 87-5-B as follows:

C. “Any and all residents and/or commercial establishments who are not connected to the Village of Maurice water system will be charged a flat rate of \$31.25.”

To also remove the following language from the previous ordinance described as follows, “residents and not domiciled in the Village of Maurice and/or not connected to the Village of Maurice water system”.
